Educational Financial Aid Application**

The American Public Works Association – Southern Arizona Branch has established an educational financial aid program to assist individuals seeking to advance careers in the field of public works. APWA-SA would like to make up to five awards of \$500 to qualified applicants in May of 2016. Financial assistance is available to individuals attending universities, colleges, and community colleges in Arizona and for other course work that will serve to establish or advance their careers.

Requirements to apply for the current APWA-SA assistance are as follows:

1. Individual must be a resident of the State of Arizona and a U.S. Citizen
2. G.P.A. of 2.8 or higher and/or evidence of success in chosen field
3. Enrollment in a program that will support a career in public works

Anyone meeting the above criteria can apply for the financial assistance; this includes high school seniors intending to enroll in course work relating to public works. In addition applicants are asked to complete a brief essay describing how their program relates to a public works career. References and descriptions of community involvement will also be reviewed as part of the application.

Funds will be distributed directly to the applicant and may be utilized for any expenses related to the completion of their course work. Evidence of enrollment will be required.

The APWA-SA Education Committee will accept applications until April 22, 2016. The applicants will be notified of the awards by May 8, 2016 and funds will be distributed upon receipt of enrollment verification.

Selection of applicants to receive awards will be made by the APWA-SA Education Committee and will be approved by the Board of Directors of the Southern Arizona Branch.
